Ffynnoncadno Nomination & Agreement Form

SWABS:

ALL visiting mares MUST have a veterinary certificate stating the mare has been swab-tested and negative against CEM, prior to their arrival at Ffynnoncadno Irish Draughts.

MARES:

We will take every care, attention and supervision possible to ensure the safety, health and condition of the mare, although Ffynnoncadno Irish Draughts will take no responsibility or liability for any accident, damage, injury, illness, disease or loss of any horse. Ffynnoncadno Irish Draughts reserves the right to consult a veterinary surgeon in the event of an emergency, accident or illness, at the owner's expense without prior notification to the owner. ALL mares are covered at their owner's risk and no responsibility will be accepted for injury, damage or loss caused through covering any mares. Any difficult mares will be twitched or sedated at the owner's expense. Ffynnoncadno Irish Draughts advise that broodmares are insured by the owners, prior to arrival at stud.

KEEP OF MARES:

All mares will have the option of pasture or stables. Ffynnoncadno Irish Draughts has the right to feed or stable any horse as they consider beneficial, with notice to the owner prior to doing so. Charges are as below:

Grass Keep - £4 per day for individual mares / £5 per day for mares with foals at foot (inc. arrival & departure days).

Stabled - £12 per day (empty mares) £15 per day (in foal & foal at foot mares) (inc. arrival & departure days).

SHOES

Mares must have hind shoes removed prior to arrival at stud. Ffynnoncadno Irish Draughts may arrange a farrier at your expense should Ffynnoncadno Irish Draughts feel mares require a trim.

WORMING:

All mares are advised to be wormed at least one week before arrival. Ffynnoncadno Irish Draughts will administer wormer to mares every 12 weeks during their stay, at the owner's expense.

STUD FEES:

Mares arrive at Ffynnoncadno Irish Draughts with their CEM certificate and passport. Final fees are due to be settled prior to/on collection of the mare. Visiting mares and/or foals may not be collected until all fees have been paid. In the event of Ffynnoncadno Irish Draughts giving notice for removal of any horse and this is not adhered to, or fees are not paid, Ffynnoncadno Irish Draughts will be entitled to sell the horse/s and out of the proceeds of sale defray the costs of the fees and for the period of notice and the sale, and the owner hereby appoints Ffynnoncadno Irish Draughts as their agents for the purpose of the sale.

SCANNING:

If the mare remains at stud, to be scanned, we aim to scan at 16-18 days, in case of twins. However, from approx. 24 days post covering, we scan again for heartbeat. Mares are scanned in stocks for safety; however, mares may need to be sedated, which will be at the owner's expense, we cannot always contact the owners first to inform them.

STUD TERMS:

No Foal, Free Return (NFFR). The stud fee in relation to NFFR entitles your mare to covering during one of her seasons with a free return for a further two of the mares' seasons, which can be done in the same year, or rolled over to the beginning of the following year should it be getting late in the season. The number of free returns is at the discretion of Ffynnoncadno Irish Draughts.

COVERING CERTIFICATES:

Ffynnoncadno Irish Draughts post covering certificates out in September/October of the year of covering, therefore, it is imperative to know if your mare is in foal and requires a covering certificate. Once a covering certificate is issued your entitlement to any further free returns are revoked.
